

### Form 2A: Disclosure Report

In this Form there are questions about your experience of abuse. You are asked to write about when and where the abuse took place and describe the person or people who abused you.

Before you make a start you may want to think about who could give you some support if you would like it.

Please ensure you give detail so your answers show the type and extent of the abuse that happened to you and provide any information you feel would assist with investigating your complaint. Remember there are no wrong answers and, know we are not looking at spelling or grammar.

### What will be shared?

### Information which Pathways may share with authorities

In certain circumstances, Pathways may be required to disclose your report of abuse to Victoria Police and/or obtain clearance from the police prior to commencing its own investigations into the matters disclosed.

Pathways may also be required to make a report to Commissioner of Children and Young People if the information you have provided discloses a 'reportable allegation' that is required to be notified.

### Information Pathways may share to investigate the disclosure

Your answers in Form 2 will be shared with the participating church authority (or authorities) they are relevant to. The relevant church authority may be a diocese or other entity associated with a church organisation or body (e.g. church, school or agency).

This exchange of information is necessary to investigate your complaint.

The relevant participating church authority will use this information to look for records they may have about you, or which might relate to the abuse and/or the person or people who abused you.

We understand some church authorities may not have records. Please do not be concerned, this will not stop your complaint from being assessed. If these questions raise any issues for you, please seek support from a person or service you trust.

If the person you have identified in the disclosure report as your abuser is alive, and Pathways is able to conduct an investigation into your disclosure (e.g. once any police investigation has concluded), the Pathways Complaints Committee may share the disclosure report with an external investigator who is appointed to provide an impartial and independent review of the facts and circumstances disclosed.



Pathways must offer that person procedural fairness. That means that person must have the opportunity to know what has been said about them and to contest the action. <u>Pathways will not</u> <u>share the Disclosure Report with that person</u>. Instead, a separate document will be prepared by Pathways summarising the specific allegations that person will need to respond to.

#### Information Pathways will share in other stages of the Pathways process

If you are eligible to engage in the Step 3: Resolution process, the Disclosure Report will assist the parties involved in that process to evaluate your entitlement to the elements of redress (for example an independent medical expert, mediator or professional representative of a participating church authority).

We will separately seek your permission to share the Disclosure Report at the commencement of the Step 3 process.

### Privacy and Collection Statement

Pathways Response Victoria Ltd (ACN 654 682 481)(**Pathways**) is collecting your personal information in order to investigate your disclosure of abuse by a person who is a member of church personnel in relation to a participating church authority and to provide you with support and care co-ordination services.

Pathways will not be able to investigate your disclosure or provide you with services if it is not able to collect this information.

Pathways is likely to collect personal information from third parties for this purpose e.g. medical providers.

As noted above, Pathways may disclose your personal information to its associated entities and third-party service providers for purposes such as investigating the abuse detailed in your disclosure, e.g. appointing an independent investigator.

### Help to answer questions in Form 2A:

In Form 2A you need to answer questions about when and where the abuse took place and tell us about the person or people who abused you. Please write as much as you are able. It is okay if you don't have an answer. Write what you can and move onto the next question.

If you experienced abuse by more than one person it is important to give us as much information as possible so that each complaint can be considered and all relevant church authorities can be identified.

The table below is included to help you identify the persons, bodies, organisations or persons you need to write about. It may also help you work out what pages you need to copy if you need to write about more than one experience. It is okay if you don't know all the details.

A statement like 'the person sexually assaulted me' does not provide enough detail to accurately reflect what happened to you or that needed to enable Pathways to ensure your complaint is properly investigated.

When you write about the abuse, you should also include related non-sexual abuse such as physical abuse, psychological abuse, cultural abuse or neglect that happened.

It is important to write separate statements if you experienced abuse by more than one person.
